



# 2025 Russell County Economic Development & CVB Storefront/Signage Grant Program

## Guidelines:

The Storefront/Signage Grant Program, through Russell County Economic Development & CVB is meant to create and enhance the promotion and physical design of businesses in Russell County. The program offers four levels of grants towards projects that include:

\***Signage** – Development or updates to signage for Russell County businesses. Signage must meet ordinance expectations and codes.

\***Store Front Improvements** – Improvements that impact current storefront. Roofing, parking lot, painting, siding/façade, windows, hardscape, etc.

Grant funds will not be provided until after the project is complete and receipts/invoices are turned in with the project final report.

**Applications are due Friday, January 3, 2025. Only one application per business per year. Once funded, businesses cannot apply for funding again for 2 years. Applications are reviewed confidentially by a committee of Economic and Community Development Professionals outside of Russell County. The total amount to be given out each year is \$12,000, number of applications awarded will vary. Grants will be awarded on a scored basis until funding is depleted. This program is meant to enhance and expand current efforts and not be the sole funding for the project. Applicants can apply for one of the four grant categories below, depending on their projects projected cost (50% match required):**

Categories:**



- 1. Investment of \$4,000 & UP = \$2,000 grant.**
- 2. Investment of \$3,000 - \$3,999.99 = \$1,500 grant**
- 3. Investment of \$2,000 - \$2,999.99 = \$1,000 grant**
- 4. Investment of \$1,000 - \$1,999.99 = \$500 grant**

**Application Requirements:**

- Submit the complete application by close of business January 3, 2025.
- Applicants must be current on Property Tax.
- All funded applicants must complete the final report and provide receipts/invoices from project expenses in order to receive funds.
- Applicant must have a business with an existing store front. If the owner of the building has no business in the facility, they will need to show a business plan for the facility once renovated.
- All updates to the facility must be within ordinances and codes.
- Project must be completed within one year after grant is awarded.

## Special Program 2025 Childcare Storefront/Signage Grant

### Guidelines:

For this year only, in partnership with NetWork Kansas, Russell County Economic Development & CVB is offering a special program to support local childcare providers. The objective of the special program is:

\***Signage** – Development or updates to signage of childcare centers or providers operating outside of their residence. Signage must meet ordinance expectations and codes.

\***Sidewalks and Fences** – Addition or replacement of sidewalk and/or fencing for childcare centers or providers operating outside of their residence.

**Applications are due Friday, January 3, 2025. Only one application per business/entity. Applications are reviewed confidentially by a committee of Economic and Community Development Professionals outside of Russell County. The total amount to be given out for this special program is \$6,000, number of applications awarded will vary. Grants will be awarded on a scored basis until funding is depleted. Applicants can apply for one of the four grant categories below, depending on their projects projected cost (50% match required):**

1. Investment of \$4,000 & UP = \$2,000 grant.
2. Investment of \$3,000 - \$3,999.99 = \$1,500 grant
3. Investment of \$2,000 - \$2,999.99 = \$1,000 grant
4. Investment of \$1,000 - \$1,999.99 = \$500 grant

**Application Requirements:**

- Submit the complete application by close of business January 3, 2025.
- Applicants must be current on Property Tax.
- All funded applicants must complete the final report and provide receipts/invoices from project expenses.
